Dear Mr. Luckman:

The Nunavut Water Board ("NWB") acknowledges receipt, on June 1<sup>st</sup>, 2015, of an revised amendment application for a Type "B" water license for water use and waste disposal associated with activities in the Kitikmeot region of Nunavut. The updated application consists of the following documents:

- Revised Cover Letter
- Revised Amendment Application

The application was distributed originally for public comments on March 26, 2015 for thirty (30) days. On May 10, 2015 Tundra Copper Corp. made the board aware that an additional item be included with the amendment application which has been submitted as a revised Amendment Application. After the comment period deadline for additional review Tundra Copper Corp. included additional information in the revised amendment application dated June 1, 2015.

Also, by copy of this letter to the Nunavut Impact Review Board ("NIRB"), the NWB requests that if the project proposal requires screening, the NIRB provide the NWB with a determination pursuant to Section 13.5.1 of the NLCA. If the project is exempt from screening pursuant to Schedule 12-1 of the NLCA, the NWB requests written confirmation from the NIRB that the project proposal is in fact exempt from screening.

To ensure this application is dealt with in a timely fashion, the NWB forwards notice of all documentation to regulators and council of the municipality(ies) most affected by the project, inviting interested parties to make representation directly to the NWB within 10 days from the

<u>date of this letter</u>. The NWB may provide additional procedural instructions once the application has been reviewed by interested parties.

Subject to Sections 12.10.2 and 13.5.5 of the NLCA, where a review is required pursuant to Article 12, the NWB shall not approve any water application that forms part of that review until Article 12 has been complied with.
