**Re: Water Licence 2BE-COP1416 – Annual Fees**

---

Tundra Copper Corp. hold water licence 2BE-COP1416 which was issued on August 28, 2014 and expired on September 15, 2016. An application for renewal was submitted to the Nunavut Water Board on September 6, 2016. An amendment was applied for and received on July 14, 2015 whereby the water volume was increased from 51m<sup>3</sup> per day to 70m<sup>3</sup> per day. Water use payments for the term of the Permit August 28, 2014 to December 31, 2016 are detailed in Table 1 below.
