The Nunavut Water Board had completed the preliminary technical review of the renewal water licence application for 2BE-COP1721. Below please find some items requiring clarification:

- The application notes that garbage will be burned and composted. Tundra Copper Corporation is reminded of the following conditions in Licence Part D:
  - 2. The Licensee shall not practice on-site land-filling of domestic waste, unless otherwise approved by the Board in writing.
  - 3. The Licensee is authorized to dispose of all acceptable food waste, paper waste and untreated wood products in an incinerator.
  - 4. The Licensee shall not open-burn plastics, wood treated with preservatives, electric wire, Styrofoam, asbestos or painted wood to prevent the deposition of waste materials of incomplete combustion and/or leachate from contaminated ash residual, from impacting any surrounding waters, unless otherwise approved by the Board in writing.
- The NWB recommends that the spill plan be revised with the addition of the contact information of the CIRNA Inspector and the spill report form.
- The NWB also recommends withdrawal of the WILDLIFE AND ENVIRONMENTAL MITIGATION PLAN, as it is
  outside the Board's mandate.
- The NWB has no record of receiving the 2019 annual report could you please submit the document?
