Good morning Nigel,

If the new drill targets are still within the Project Extents included in the Licence, you do not need an Amendment to the Licence. You need an Amendment to the Licence if the Project Extents are to be changed with the new drillings planned.

Looking at the coordinates for the future drills provided i see that those points are outside of Project Extents, therefore yes, an Amendment to the Licence is needed for the future drillings, and a complete Amendment application package shall be submitted to the Board. However, the NWB does not need at this stage the exact drilling locations. Just new Project Extent coordinates should be provided. The Board requires all water sources and waste disposal locations to be included within the Annual Reports. Therefore, the relevant precise locations could be included within the Annual report.

From my understanding a new camp is also proposed? If yes, the new camp related information shall be included within the Remote Camp Questionnaire to be included within the Amendment application package. Also, information should be provided regarding the reclamation (final or progressive) of existing camp(s) within an updated Abandonment and Restoration Plan that shall also include information regarding the new camp(s).

Also, I believe the attached Fuel Contingency Plan is addendum to the original Spill Contingency Plan that was approved by the Board with the License issuance?

Please submit the complete Amendment application to the NWB Licencing department, and if you have questions with that respect let the Licensing Administrator Robin know.

I am currently preparing Tundra Copper's application for a new Class A Land Use permit (as the Class B does not allow us more than 400 man-days in camp) and an amendment to Tundra's existing water licence 2BE-COP1416. Although Kaizen Discovery Inc has acquired Tundra Copper Corp., we intend to use Tundra as our operating entity in Nunavut (see attached news release and share certificate).

Zach mentioned to me that you would review the application for the water licence amendment. Since we intend to use the same camp location as defined in Tundra's original application, and will not be using more water than the amount in that licence (2BE-COP1416), we would like to apply for an amendment as we propose to drill different targets than those noted in the original application.

For the amendment I am sending:

An updated the Fuel Contingency Plan to reflect requests made by AANC.

A map showing the amended drill hole locations.

A list of new, proposed drill site coordinates.

I haven't sent all the original documents that were used for the initial water licence application, but can if necessary.

I would appreciate it if you wouldn't mind review the documents and letting me know if there are any other documents that I should include or edits that I should make.
