
A. BACKGROUND

The Coppermine Project under licensee Tundra Copper Corp. is located approximately sixty (60) kilometers southwest of Kugluktuk in the Kitikmeot region of Nunavut. Kugluktukmiut Inuit have lived, hunted and relied on these lands for thousands of years. The Coppermine Project is located on Crown Land administered by CIRNAC and Inuit Owned Land (IOL) administered by the Kitikmeot Inuit Association (KIA). Tundra Copper Corp. applied for a water licence renewal in 2021 that doesn't include Inuit Owned Land (IOL) administered by the Kitikmeot Inuit Association (KIA).

The mineral exploration project was changed to an Abandonment and Reclamation Project, and was inspected by CIRNAC field inspectors in 2017. Their report came back as satisfactory. The licensee Tundra Copper Corp. requested to renew their Type B water licence in 2021 to keep it in good standing for future planned exploration across their Coppermine claims till July 20, 2026. This current review is for their 2021 Annual Report.

Project activities included exploration for copper mineralization using geochemical soil and rock sampling surveys, prospecting, 2,000 meters of core diamond drilling in five holes, 500 meters of trenching to evaluate and verify previously discovered copper deposits, and geological mappings.

CIRNAC provides the following comments and recommendations pertaining to the Type B Water Licence 2021 Annual Report 2BE-COP1721 which contains all project activities undertaken by the licensee for the year 2021.

C. RESULTS OF REVIEW

 Crown-Indigenous Relations and Northern Affairs Canada's Comment on Tundra Copper Corp. Application for Renewal of Type B Water Licence No. 2BE-COP1721

Comment:

CIRNAC was invited by the Nunavut Water Board (NWB) to review Tundra Copper Corp.'s Type B Water Licence 2BE-COP1721 renewal application and submit comments by August 12 2021. CIRNAC submitted its review with comments and recommendations on August 31 2021.

It is unclear if the licensee responded to CIRNAC comments during the renewal process as no record of their response could be found on NWB registry.

CIRNAC's concern in its review comment number R-03 during the 2021 renewal application process is resolved as the 2019 annual report requested in the comment has been found.

Recommendation:

(R-01) CIRNAC recommends that the licensee:

- Clarify whether response to CIRNAC comment during the renewal application process was provided; and
- Provide the copy of their response, if a response was issued.

2. Water Rights of Existing and Other Water Users


Comment:

Section number 18 in the Water Licence Renewal application states:

'18. WATER RIGHTS OF EXISTING AND OTHER WATER USERS

Are the effects of the undertaking on any known persons or property including those that hold licences for water use in precedence to the application, domestic users, in-stream users, authorized waste depositors, owners of property, occupiers of property, and/or holders of outfitting concessions, registered trapline holders, and holders of other rights of a similar nature, the same as those considered in the existing water licence?

Provide the names, addresses and nature of use for any known persons or properties that may be adversely affected by the proposed undertaking, including those that hold licenses for water use in precedent to the application, domestic users, in-stream users, authorized waste depositors, owners of property, occupiers of property, and/or holders of outfitting concessions, registered trapline holders, and holders of other rights of a similar nature.

Tundra Copper Corp.'s response: 'There are no other users of water in the area that we are aware of. We will be in a remote area.'

The licensee's use of the term 'remote area' as a yardstick to determine that there will not be any other users of water in the area is unfitting because Inuit travel thousands of miles to engage in hunting activities, camp and fish, and be on the land all over Nunavut. People in the closest community could be impacted irrespective of the location of the activities.

Recommendation:

(R-02) CIRNAC recommends that the licensee clarify whether the community of Kugluktuk as the closest community was duly consulted during the application for renewal process.

The 2021 Annual Report was satisfactory as the Licensee did not conduct any activity on the Coppermine site in 2021, there was no water used or waste produced.
