RE: Application for renewal of Water Licence 2BE-CRA1015

Dear Ms Beaulieu.

North Country Gold Corp. (NCGC) would like to request a renewal and extension to water licence 2BE-CRA1015 for the Committee Bay Project (CBP) located in the eastern Kitikmeot region of Nunavut Territory. NCGC is requesting a renewal and extension of the licence for an additional 10 years from April 01, 2015 through to March 31, 2025 to support ongoing exploration activities at the project.

Please find attached to this letter a completed Nunavut Water Board (NWB) Water Licence Renewal Form and the requested supporting information.

Scope of activities

This renewal application does not request any change in the scope of work activities for the project. Camp capacities, water use and waste disposal, exploration work activities and infrastructure improvement activities remain consistent with previous authorizations. In summary this includes:

- Operation of Hayes, Bullion, Ingot and Crater Camps including associated water use of up to 50m³ per day and associated waste disposal
- Use of up to 7 diamond core drills including water use of up to 245m³ per day
- Use of up to 2 RC drills (Super Hornet or equivalent) no water use required
- Airborne and ground geophysics
- Rock, till, soil sampling and geological mapping
- Haves Camp infrastructure upgrades
 - Ongoing construction of 3000' Hayes Camp airstrip
 - Future construction of all-weather access trail between Hayes Camp and Three Bluffs gold deposit and drilling area
 - Quarrying (and use of explosives where necessary) for airstrip and road construction
- Storage of up to 6000 drums of diesel and aviation fuel to support exploration activities.



Previous screening

The scope of activities outlined above has been previously been reviewed by the Nunavut Planning Commission and found to be in conformity with the Keewatin Regional Land Use Plan. This information is attached as Appendix 2 of the water licence renewal application. In addition, these activities were screened by the Nunavut Impact Review Board under section 12.4.3 of the Nunavut Lands Claim Agreement (NLCA). Project specific terms and conditions have been applied in accordance with section 12.4.4(a) of the NLCA. Screening information is provided as Appendix 3 of the water licence renewal application.

Management Plans

NCGC's management plans have been reviewed, re-written and updated accordingly. Plans are listed in Table 1. Updated plans are attached to this application.
