A. PROJECT DESCRIPTION

On Oct. 28/10 the Nunavut Water Board distributed notification North Country Gold Corp.'s Oct. 25/10 request to assign the Committee Bay Project licence to their name from CBR Gold Corp. pursuant to Section 44 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*. As explained in their submission, following a corporate split to CBR Gold Corp. the Committee Bay Project and related assets were transferred to a new corporation named North Country Gold Corp. Interested parties were requested to review this submission and provide written representations by Nov. 28/10.

B. RESULTS OF REVIEW

On behalf of the Indian and Northern Affairs Canada Water Resources Division I have reviewed the submitted licence assignment request. Following an assignment of this licence, North Country Gold Corp. must ensure that all plans required by the licence reference their company name, current contact information, and include any revisions required by changes in operations and/ or technology. Revised plans should be submitted to the Board before the upcoming field season.
