**RE: ADDITIONAL INFORMATION FOR 2008 ANNUAL REPORT  
INAC LAND USE PERMIT N2008C0030 – NIRB FILE NO. 08EN059  
SOUTH BAKER/DUBAWNT LAKE PROPERTY, NU  
URANIUM NORTH RESOURCES CORP.**

Further to your 15 April 2009 letter that identified deficiencies in our Annual Report on the 2008 exploration activities at our South Baker/Dubawnt Lake Property. This letter will serve as an addendum to the Annual Report and supplies information for the highlighted points in your letter. As well corrections were made to the typographic errors contained in the original Annual Report and the corrected document is also included.

Your letter noted the following deficiencies that are bulleted below with our information following each point:

- A work plan for the following year, including any progressive reclamation work to be undertaken; **please indicate if work will or will not occur on site in 2009, and if so what activities.**

At this time, the only work planned for the South Baker Project is a detailed airborne magnetic and radiometric survey, to be completed in July 2009.

- A *Wildlife Monitoring Report* to include requirements as listed in the Screening Decision Report Monitoring and Reporting Requirements #2; **please provide the information specified above.**

The 2008 program was operated by a consulting company, MPH Consulting Limited of Toronto. Such records were not kept during the 2008 program by MPH. In the future Uranium North will be implementing a more rigorous record-keeping program that will include detailed daily logs of exploration activities and wildlife monitoring.



- Site photos; **please provide photographic evidence.**

MPH Consulting did not provide site photographs from the 2008 exploration program.

- Efforts made to achieve compliance with the *Canadian Wide Standards for Dioxins and Furans*, and the *Canadian Wide Standards for Mercury*; **please provide some indication of compliance or planning.**

At present a camp has not been constructed on the property. All 2008 exploration program personnel were housed off the property at the Tukto Lodge Outpost Camp located in the southern Dubawnt Lake area. Crews were transported to and from the field area by helicopter for the entire field season.

Should Uranium North construct a camp as included in the original application a fuel-air-fired incinerator will be put in place for use to incinerate paper products, paperboard packaging and untreated wood wastes only. As well Uranium North will work towards reducing superfluous packaging materials brought to the camp/property and will transport waste materials not suited for incineration to a specific landfill location property as often as practicable in an effort to reduce, reuse and recycle.

- **Section clarification:** *Summary of 2008 Field Activities* refers to 2009 dates for past year's activities, and Figures 4 and 5 which are not included in the report.

These items represent typographic errors in the original report. The corrected 2008 Annual Report is included with corrections made to these errors. The "2009" reference should in fact have read "2008". As well "Figures 4 and 5" should have read "Figures 2 and 3".

I wish to advise that upon taking up my position with Uranium North I was disappointed to learn that Uranium North's management did not ensure that the company in charge of the 2008 exploration program, MPH Consulting Limited, took the necessary steps to follow the requirements of the NIRB Screening Report and Land Use Permit and Uranium North's stated intentions as put forward in the original land use permit application. The importance of the information that is to be supplied is significant for various agencies in the North to obtain from exploration companies working on the land.

In future all efforts will be taken to ensure that Uranium North personnel, contractors and consultants will be fully versed in the contents of the permits, licences and related land use documents, including the requirements of gathering the necessary data during all future exploration programs. A record-keeping procedure is being instituted. Uranium North will ensure the intentions as stated in the original land use permit application and the requirements as described in the NIRB screening report and INAC land use permit are followed fully.

During the first two weeks of May I will be in Rankin Inlet and Baker Lake to meet with representatives of the Kivalliq Inuit Association, the federal government, and other regulators and agency members in



an effort to introduce them to Uranium North, its philosophies and properties. A more formal consultation program will be conducted during the summer months.
