Dear Mr. Kablalik,

I am in receipt of your letter dated November 14, 2011 and your inspection report for the NW Edehon Lake Old Airstrip.

Firstly, I apologize for the lateness of this reply. The address you had used for the correspondence is out of date and consequently, the letter was delayed in its delivery. Please update your records to the address on the letterhead above. Also, Tri Origin's land manager left the Company at the end of 2011. It would be best if you directed future correspondence to me.

After reviewing your report and attached photographs, I understand your concern and requirement to have the site cleaned up. The purpose of this letter is to clarify that Tri Origin did clean up the site through a contract with Henik Lake Adventures and removed all of its work-related materials (excepting drill core) on its departure in September of 2007. Tri Origin believes that it has fulfilled its responsibilities and no other action is required by the Company.

A turnkey camp facility was rented for the month of July and until August 7, 2007 from Henik Lake Adventures. Tri Origin expedited camp supplies and logistics required for its 2007 exploration program through Eskimo Point Lumber a related company to Henik Lake Adventures, both controlled by Ryan St. John of Arviat. Tri Origin also employed a cook and Steven Cochrane a Camp Supervisor who was responsible for ensuring camp safety, site cleanliness, coordination of logistical services and mobilization and demobilization of camp materials. Mr. Cochrane was employed under separate contract with Eskimo Point Lumber.

Under the terms of our contract, Tri Origin was responsible for payment of aircraft flights and labour related to the clean-up of the site following the completion of its work. Tri Origin made arrangement through Henik Lake Adventures to have fuel drums, propane cylinders and other materials used for its exploration program removed from site. Work was completed and all invoices were paid.

In addition, during the course of Tri Origin's demobilization, Ryan St. John informed Tri Origin that he would be keeping the camp open for Caribou hunts and other activities. He requested at the time that tents, some camp materials and unused propane and fuel be left for future use. Tri Origin agreed to

this. My understanding is that the site was used on occasion after August 2007 and as recently as last year by Henik Lake Adventures.

I have attached emails recovered from our files recording the demobilization of the camp during September 2007.

Please contact me if you require additional information to complete the closure of Tri Origin's Land Use Permit.
