Dear Ms. Beaulieu,

Thank you for your email of July 13th. As you have requested, I have attached information regarding Tri Origin's request for cancellation of its 2007 water licence in response to the AANDC correspondence dated January 30, 2012 that you forwarded to me.

As we discussed on the phone last week, Tri Origin completed its work in 2007 and left the camp clean and in good order. At the time of Tri Origin's tenure at the camp, Henik Lake Adventures and affiliate company Eskimo Point Lumber owned and operated the camp and acted as expediter for Tri Origin. Upon completion of our program, exploration related materials were removed from the camp. Additional flights were contracted to remove all fuel drums from the site. Mr. St. John of Henik Lake Adventures requested that some remaining camp materials be left with him so that he could use them for future expediting during the coming hunting season. During the Company's program, all drill sites and sumps were remediated and no drill cuttings were left at drill sites. I have also forwarded a table of GPS co-ordinates for all drill sites to your attention should additional inspection be required.

The camp and adjacent airstrip has been used on many occasions since 2007. Tri Origin has had no control over the use of the landing strip or the Henik Lake Adventures camp site for mineral exploration or hunting purposes since 2007. By coincidence, I was in contact with a contractor who was based out of the camp last summer while working for Uranium North Ltd. who also used Henik Lake Adventures as expediter and have been told about other groups who have used the airstrip and site as a staging point for their projects over the past few years. Tri Origin has no way of verifying the condition of the site since its departure in 2007.

Tri Origin has also dealt with the issues discussed in your correspondence in regard to the Company's land use permit. Information was forwarded to Mr. Kablalik and Mr. Keim at the time. I have attached some of this information for your consideration. Please note in the attached documents the email correspondence from 2007 stating that the site was left in clean condition, invoices for clean-up and payment verification for flights to remove fuel drums and other camp waste.

I trust that this information and your review of this material will meet with your satisfaction and the expired water license will then be cancelled. Please contact me with any other questions you may have. Thank you for your assistance.
