**Re: COMPLIANCE PLAN SITE CLEAN-UP N2005C0036**

Dear Christine,

In response to your email of July 18, 2013, to finalize the cancellation of its work permit number **N2005C0036** and related water use permit, Tri Origin intends to complete the site clean-up of its 2007 staging site near Edehon Lake. The site clean-up was originally completed in 2007 upon completion of Tri Origin's field program. Subsequent use by others has resulted in the accumulation of materials at the site. The most recent information reported to Tri Origin indicates that all material which may be the responsibility of Tri Origin from the 2007 camp site occupied by Tri Origin and rented from Henik Lake Adventures, has been transferred to the nearby Edehon Lake airstrip. This material consists of a number of 45 gallon fuel drums and propane cylinders. It is my understanding that all other campsite materials and waste have been removed from the campsite and the campsite has been rehabilitated and abandoned by Henik Lake Adventures, the owner of the camp.

Tri Origin believes that its responsibilities and requirements to complete the cancellation of any outstanding work and water permits are to remove the materials related to its activities from the Edehon Lake airstrip and have these materials properly disposed of or recycled.

The removal of these materials and any related restoration resulting from their storage at the airstrip is to be completed by September 30, 2013.

The implementation of the compliance plan and flights to the airstrip will commence on or about August 9<sup>th</sup> and it is intended that site-related activities will be completed prior to the end of August. In addition, Tri Origin will arrange to have site visits conducted at the 2007 camp site to ensure that it has been

properly restored as per the reports it has received from Henik Lake Adventures. Any additional materials of Tri Origin's remaining at the site will be transported to the nearby airstrip. Tri Origin's contractors will complete the flights required to remove all materials related to its activities from the Edehon Lake airstrip to Arviat, NU, Churchill or Thompson MN depending on flight parameters and contractor logistics. At the final destination waste will be disposed of at appropriate municipal facilities and where possible drums and propane cylinders will be recycled for use by local contractors.

Tri Origin will use licensed contractors including, as required, the assistance of Henik Lake Adventures and charter air transport services based out of Thompson Manitoba to transport materials from the airstrip to their final destination. Sub-contracted labour will be employed for site restoration and clean-up as required. All contractors and sub-contractors will provide proof of insurance.

Following the completion of the compliance plan, Tri Origin will report to the inspector all work undertaken and the status of the site on completion of the work. The report will be accompanied by photos of the airstrip and any areas restored.

The airstrip is in continuous use by a number of parties as a staging area and fuel cache. It is important for this compliance plan that the inspector recognize that Tri Origin will transport materials that it is responsible for from the airstrip to the final destination. The Company cannot be responsible for materials and empty or full fuel drums currently being left at the site by others or materials which will be left there after it completes the work laid out in this compliance plan.
