Hi Robin,

Thanks very much for getting back to me regarding our file.

I am aware that we submitted the original cancellation application in July 2011, and since then we have received notices from AANDC saying that our license is still active and the site needs to be immediately cleaned up in order for the license to be cancelled. We recently had Ookpik Aviation do the clean up job at the site (in August 2014). I'm just wondering if we need to re-submit the cancellation application form, or if the NWB will reassess the original application, or if the NWB requires anything else from us in order to process the cancellation. When can we expect the water license to be cancelled? We haven't worked at this site since 2007 and have no plans to return there.
