In reply to your email, Tri Origin has made progress on the Compliance Plan however it has been at a much slower pace than we had anticipated. The Company has been working with Wings over Kississing Air Service based at Thompson, Manitoba and Ryan St John at Arviat to have the site cleaned up. At this stage, pickup of fuel barrels and propane tanks remains outstanding.

Tri Origin contracted Kississing in the fall of 2013 to schedule a series of flights to the Edehon Lake airstrip to pick up barrels. They were only able to make one flight due to scheduling issues with their turbo Beaver. They are now on hold until late winter when some of the snow melts and the site can be accessed by their Beaver on skis.

In addition, Ryan St John of Henik Lake Adventures had agreed to transport a drum crusher to site and coordinate flying crushed drums out with an Otter accessed from Baker Lake in conjunction with other flights he had scheduled to the area during the late fall. He later reported to Tri Origin that his drum crusher was not operational. Although he ensured us that it would be fixed prior to the onset of winter, we were unsuccessful in having him complete the work during 2013.

Recent discussions with Mr. St John have set a plan for him to access the site with a snow machine, trailer and drum crusher during April. He has indicated that he is able to undertake this work and is scheduled to do so. As many barrels will be removed overland by trailer as is feasible. This will be followed up by Kississing flights when the airstrip is suitable for landing.
