Thanks for taking my call earlier.

As identified in your email below, January 14th is the deadline to submit comments for Baffinland's Ege Bay Type B water Licence application (2BE-EQE).

So that the NWB is aware, QIA has been in direct discussion with the proponent regarding some aspects of the Type B application. In December, QIA submitted to the proponent a gap analysis document to allow them the opportunity to address our concerns directly prior to our technical submission to the NWB. QIA has just received a response from Baffinland this week and requires more time to review and update our comment submission, taking into consideration the information that the proponent has provided.

QIA would like formally request a 1 week extension, from January 14th, to submit comments to the NWB. Upon submission of our comments, the QIA will also include the correspondence between QIA and Baffinland so that it can form part of the public record.

I hope that this request is reasonable at this time and we look forward to hearing your response.
