Hello Assol,

As Baffinland did not receive any comments from QIA on the Closure and Reclamation plan strategy and objectives for the closure of roads and the airstrip through the Type B process or the land lease application. While an agreement with QIA has not been signed at this time, we consider the closure plan put forth sufficient to meet the objectives outlined. Further discussions with QIA will involve the calculation of reclamation securities and the potential for QIA to hold securities for this exploration program, however it is anticipated this will not change the closure strategy, only the value for the reclamation works.
