2023 NUNAVUT WATER BOARD (NWB) ANNUAL REPORT FOR EXPLORATION ACTIVITIES

EXECUTIVE SUMMARY

This report to the Nunavut Water Board (NWB) has been prepared to summarize the 2023 exploration activities conducted under Baffinland Iron Mines Corporation's (Baffinland) Type 'B' Water Licence 2BE-EQE1926 (Type 'B' Water Licence) for the Ege Bay Project (the Project).

The scope of the Type 'B' Water Licence focuses on exploration and drilling activities and includes provisions and conditions regarding water use, waste management, construction and operation of satellite camps, exploration and drilling programs, spill contingency and environmental monitoring.

As per Section 147 of the Nunavut Planning and Project Assessment Act, the Ege Bay Exploration Program Project Proposal commenced with surface sampling and an archeological survey of the area in 2018. Activities in 2019 included geological and structural mapping, grab sampling and ground geophysical surveys. In 2021, a geophysics survey, till sampling, geologic mapping, permafrost, and archaeological survey were completed. Further approved activities and infrastructure (drilling program, camp infrastructure, etc.) will proceed once all required surface approvals are obtained (including a land lease for IOL).

During 2023, there were no activities carried out under the scope of the Type 'B' Water Licence due to restricted access to the majority of the land tenure. Access to IG-02 and IG-03, host to Crown mineral claims and a Nunavut Tunngavik Inc. Mineral Exploration Agreement respectively, is currently restricted due to difficulties in securing a Land Use Licence II from the Qikiqtani Inuit Association (QIA). Camp development and advanced exploration activities such as drilling are concurrently restricted by difficulties in securing a Land Use Lease from the QIA.

As there was not human presence or infrastructure in the Project area in 2023, environmental monitoring was not performed.

As no development or earthworks has happened in the Project area to date, no reclamation works have been carried out under the Type 'B' Water Licence.

Exploration activities for 2023 have not yet been finalized however it is possible that activities will include mapping, sampling and geophysical and geochemical surveys of prospects in the Project area. Notification will be provided to the NWB, CIRNAC and the QIA prior to the commencement of exploration and/or drilling activities. Should Project activities resume, Baffinland will engage with community members to discuss planned developments and employment opportunities that may exist as the project moves forward. Should Project activity resume, Baffinland plans to continue to engage as many local employees as possible and provide on-the-job training to positions relevant to grassroots exploration.

During 2023, Baffinland may look to establish a new exploration camp within the Ege Bay Area to support a drilling program as well as other low impact exploration activities within the Ege bay Area. The current Type 'B' Water Licence issued in April 2019 is inclusive of the scope of these activities. New Land Use

Licence and Land Use Lease applications would have to be lodged with and approved by the QIA, that would allow for low-impact exploration work (Land Use Licence) the development of the camp and exploration drilling on Inuit owned land (Land Use Lease).

RAPPORT ANNUEL 2023 DES ACTIVITÉS D'EXPLORATION PRÉSENTÉ À L'OFFICE DES EAUX DU NUNAVUT (OEN)

RÉSUMÉ

Le présent rapport adressé à l'Office des eaux du Nunavut (OEN) a été préparé pour résumer les activités d'exploration menées en 2023 dans le cadre du permis d'utilisation des eaux de type « B », 2BE-EQE1926 de Baffinland Iron Mines Corporation (Baffinland) (permis d'utilisation des eaux de type « B ») pour le projet de la baie d'Eke (le projet).

Le permis d'utilisation des eaux de type « B » porte sur les activités d'exploration et de forage, et comprend des dispositions et des conditions concernant l'utilisation de l'eau, la gestion des déchets, la construction et l'exploitation de camps satellites, les programmes d'exploration et de forage, les mesures d'urgence en cas de déversement et la surveillance environnementale.

Conformément à l'article 147 de la Loi sur l'aménagement du territoire et l'évaluation des projets au Nunavut, la proposition de projet du programme d'exploration de la baie d'Eke a commencé par un échantillonnage de surface et une prospection archéologique de la zone en 2018. Les activités de 2019 comprenaient la cartographie géologique et structurale, l'échantillonnage par grappillage et des levés géophysiques au sol. En 2021, un levé géophysique, un échantillonnage de tills, une cartographie géologique et des prospections archéologique et du pergélisol ont été réalisés. D'autres activités et infrastructures approuvées (programme de forage, infrastructures du campement, etc.) seront mises en œuvre une fois que toutes les approbations de surface requises seront obtenues (y compris un bail commercial de la QIA).

En 2023, aucune activité n'a été menée dans le cadre du permis d'utilisation des eaux de type « B » en raison de l'accès restreint à la majorité du régime foncier. L'accès aux zones IG-02 et IG-03, faisant l'objet, respectivement, de titres miniers pour les terres de la Couronne et d'une entente d'exploration minière de Nunavut Tunngavik inc., est actuellement limité en raison de la difficulté à obtenir un permis d'utilisation du sol II auprès de la Qikiqtani Inuit Association (QIA). Les activités d'aménagement de campement et d'exploration avancée comme le forage sont actuellement limitées par la difficulté à obtenir un bail d'utilisation des terres auprès de la QIA.

Comme il n'y a eu aucune présence humaine ni infrastructure dans la zone du projet en 2023, aucune surveillance environnementale n'a été effectuée.

Étant donné qu'aucuns travaux d'aménagement et de terrassement n'ont été entrepris dans la zone du projet à ce jour, aucuns travaux de remise en état n'ont eu lieu en vertu du permis d'utilisation des eaux de type « B ».

Les activités d'exploration pour 2023 n'ont pas encore été finalisées; cependant, on prévoit que les activités comprendront au minimum la cartographie, l'échantillonnage et les levés géophysiques et géochimiques des perspectives dans la zone du projet. Des avis seront envoyés à l'OEN, à RCAANC et à la QIA avant le début des activités d'exploration ou de forage. S'il y a reprise des activités du projet,

Baffinland communiquera avec les membres de la collectivité pour discuter des développements prévus et des occasions d'emploi potentielles si le projet va de l'avant. Si les activités du projet reprennent, Baffinland planifie de continuer à embaucher le plus grand nombre d'employés possible à l'échelle locale et de fournir une formation en cours d'emploi aux titulaires de poste liés à l'exploration hors chantier.

Au cours de 2023, Baffinland pourrait envisager d'établir un nouveau campement d'exploration dans la région de la baie d'Ege en appui à un programme de forage, ainsi que d'autres activités d'exploration à faible impact dans la zone de la baie d'Ege. Ces activités s'inscrivent dans la portée du permis d'utilisation des eaux de type « B » émis en avril 2019. Il faudrait déposer de nouvelles demandes de bail et de permis d'utilisation du sol auprès de la QIA et obtenir son approbation pour des travaux d'exploration à faible impact (permis d'utilisation du sol), l'aménagement du campement et le forage d'exploration sur des terres appartenant aux Inuits (bail d'utilisation du sol).

1 INTRODUCTION

1.1 PURPOSE AND SCOPE

This report to the Nunavut Water Board (NWB) has been prepared to summarize the 2023 exploration activities conducted under Baffinland Iron Mines Corporation's (Baffinland) Type 'B' Water Licence 2BE-EQE1926 (Type 'B' Water Licence) for the Ege Bay Project (the Project). Concordance tables referencing where in this report annual reporting requirements outlined in the Land Use Licence and Type 'B' Water Licence have been met are presented in Appendix B.

The scope of the Type 'B' Water Licence focuses on exploration activities and includes provisions and conditions regarding water use, waste management, construction and operation of satellite camps, exploration drilling programs, spill contingency and environmental monitoring. Activities and data discussed in this report are summarized and referenced in the completed NWB Annual Report Forms, included as Appendix C of this report.

During 2023, there were no activities carried out under the scope of the Type 'B' Water Licence.

Figures 1 and 2 show the location of the Project relative to other Baffinland infrastructure. Figure 3 shows the proposed camp location and initial drilling area relative to Ege Bay.

1.2 REGULATORY FRAMEWORK

Although the key regulatory and legal document that relates to this report is the Type 'B' Water Licence, this report is presented in the context of other applicable regulatory authorizations and schedules for the Project. A list of the key regulatory permits, approvals and authorizations that allowed for the work to be completed at the Project in 2023 is presented in Table 1.1 below.

2 EXPLORATION ACTIVITIES

2.1 EXPLORATION ACTIVITIES AND DRILLING PROGRAMS

During 2023, no activities of any kind were carried out on the Project.

No new satellite camps were constructed and/or operated to support exploration activities in 2023. There were no drilling activities, construction of sumps, use of water or discharge of water or waste to the receiving environment.

3 MODIFICATIONS, INFRASTRUCTURE CHANGES AND CONSTRUCTION

There was no development, construction or earthworks activities initiated at the Project in 2023. Development of the Ege Bay Exploration Camp was deferred to 2023 or later due to the denial of the Land Use Lease application with QIA.

A survival shack was mobilized in 2019 to the exploration area on IG-03 Inuit Owned Land. It was slung, intact, from the Steensby Camp and placed on rocky ground to avoid any damage to the tundra. The shack was used in 2021 and remains winterized and left in place for the 2023 field season (Figure 4). The survival shack is a stand alone structure stored only with emergency survival packs and no other amenities. This was authorized via correspondence with the appropriate QIA representative. 4 WATER USE

4.1 QUANTITIES OF FRESHWATER USED FOR DOMESTIC PURPOSES

During 2023, water was not withdrawn under the authorization of the Type 'B' Water Licence for domestic (camp) purposes. No satellite camps were operated to support exploration and drilling activities in 2023.

4.2 QUANTITIES OF FRESHWATER USED FOR DRILLING ACTIVITIES

During 2023, water was not withdrawn under the authorization of the Type 'B' Water Licence for drilling purposes.

5 ENVIRONMENTAL MONITORING

5.1 ENVIRONMENTAL MONITORING FOR DRILLING/TESTING ACTIVITIES

No environmental monitoring for drilling/testing activities occurred as there were no drilling activities executed in 2023.

5.2 AIRCRAFT FLIGHTS

No aircraft flights related to the Project occurred in 2023.

5.3 WILDLIFE LOGS

Due to lack of Project activity, no wildlife was observed or recorded in 2023.

5.4 LAND USER LOGS

Due to lack of Project activity, no Land User activity was observed or recorded in 2023.

6 WASTE MANAGEMENT

During 2023, no camps were installed or operated at the Project. Therefore, waste management is not required at this time.

7 REPORTED INCIDENTS

7.1 SPILLS

There were no spills observed or reported by Baffinland in 2023 at the Project.

7.2 HEALTH & SAFETY INCIDENTS

No health & safety incidents were reported to the QIA and/or the Workers' Safety and Compensation Commission (WSCC) that pertained to the Project activities in 2023.

8 RECLAMATION, CLOSURE AND FINANCIAL SECURITY

8.1 PROGRESSIVE AND FINAL RECLAMATION

No infrastructure, construction or earthworks activities were completed in 2023. As such, there is no progressive or final reclamation to report on. Details on the progressive and final reclamation for the Project are outlined in the Ege Bay Exploration Program Closure and Reclamation Plan (BAF-PH1-400-P16-0003).

8.2 CURRENT RESTORATION LIABILITY

There is currently no financial security held for the project by the QIA or NWB under the Type 'B' Licence.

9 PLANS, REPORTS AND STUDIES

9.1 SUMMARY OF STUDIES REQUESTED BY THE BOARD

Due to the limited scope of work executed in 2023, studies under the Type 'B' Water Licence were not required.

9.2 REVISIONS TO PLANS, REPORTS AND MANUALS

Final versions of the management plans developed for the Type 'B' Water Licence were submitted to the NWB in February, 2019. Table 9.1 provides a complete list of management plans for the Project.

10 PUBLIC CONSULTATIONS

10.1 ENGAGEMENT ACTIVITIES

Due to the lack of Project activities in 2023, no engagement activities were carried out in relation to the Ege Bay Project.

11 2024 EXPLORATION ACTIVITIES

The 2024 Work Plan for the Mary River Project was prepared and provided by Baffinland to relevant parties on December 15, 2023 including planned exploration activities.

The scope of Baffinland's Type 'B' Water Licence allows for Baffinland to continue to undertake exploration activities within the Project area including mineral claims staked on crown land and IG-02 and the NTI Exploration Agreement Subarea C on IG-03, with the later areas contingent on approved QIA Land Use Licence II approval.

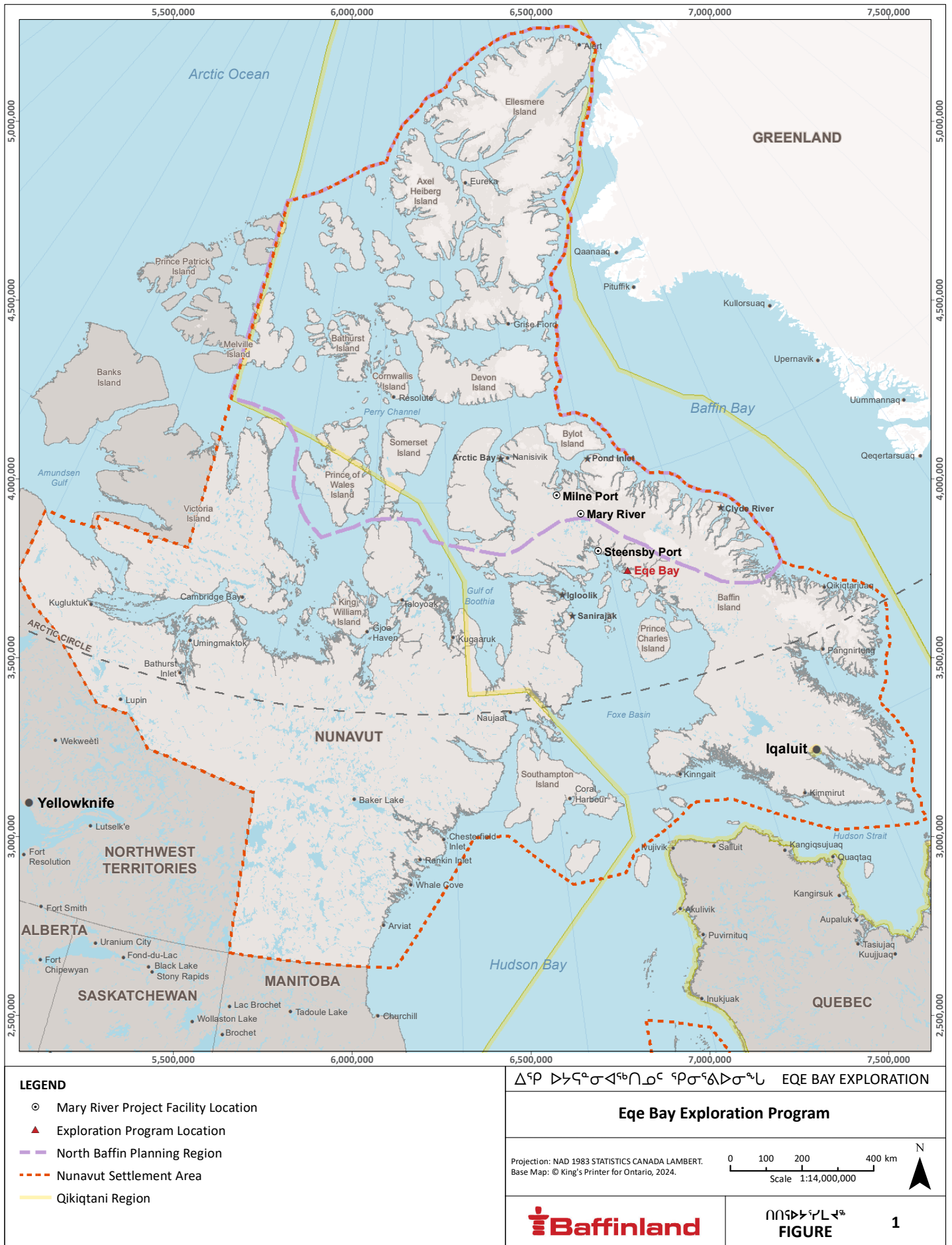

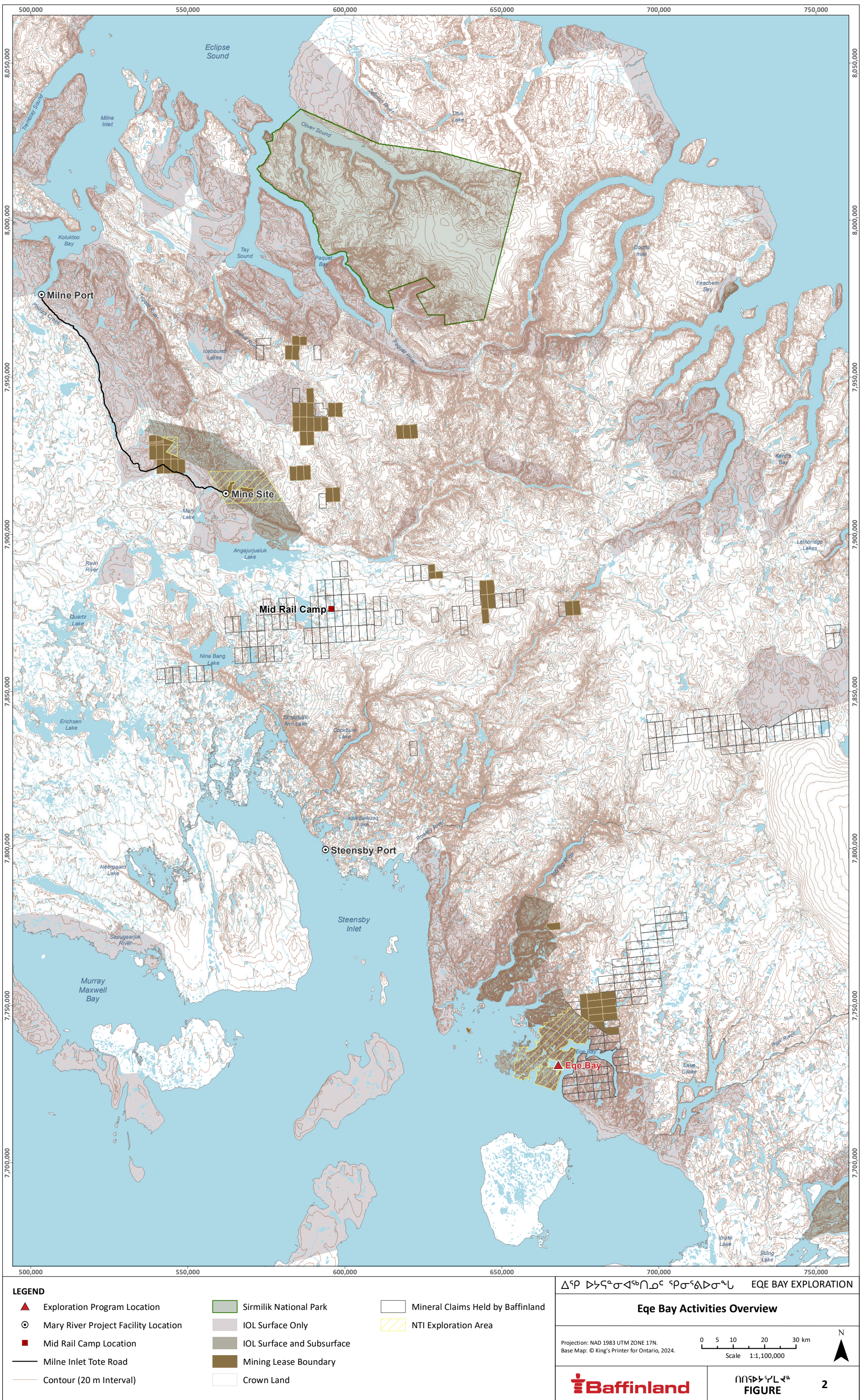

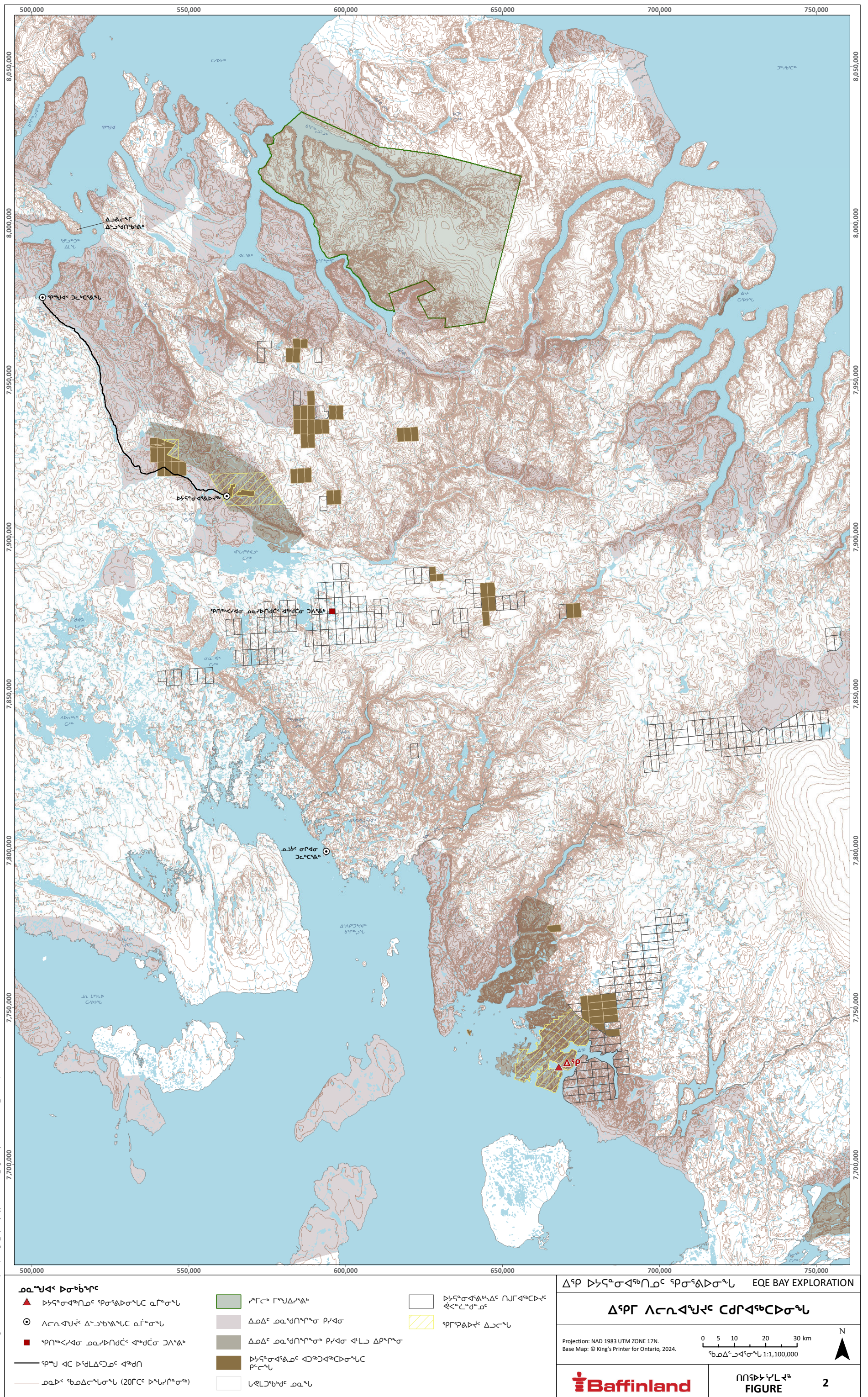
