Good afternoon Brian,

I am emailing to clarify the status of the above noted file and whether the project proposal will

require an NPC Conformity Determination.

Here a little breakdown of the events we have had today:

-email between NPC (Bobby) and NWB (Richard) forwarded to the NIRB (Tannis) stating that NPC will not be doing a conformity determination on the file because the project location is not within boundaries of a RLUP, resulting in the NIRB being triggered for our screening process

-later I received a phone call from NWB stating that you confirmed that you will commence a conformity determination against the Keewatin Regional Land Use Plan, and this resulting in our process being halted.

After the NIRB looked at the location of the proposed project, it was determined that the IOL Parcel the proposed project is located on, does fall outside of the Keewatin RLUP. So now we are a little confused with the string of emails and events for this file.

The NIRB is ready and willing to commence screening of this project, once we have confirmation from you or the proponent on the actual location of this project proposal. To make things easier for the both of our offices, and if they are available, can you please forward any shapefiles you may have on file for this project proposal?
