Hi Phyllis,

The review letter would be enough to trigger a NIRB screening if the application was for a Type A water license, or required a Water Board hearing. This appears to be a Type B permit which is exempt from NIRB screening under Schedule 12-1 (5) of the NLCA.

At this point we have received the Proponent's NIRB Part 1 and 2 forms which indicate further applications with INAC. I contacted INAC to see if there has actually been an application submitted, if the application would be a Class A which would require a NIRB screening, or if the application was for a Class B which would also be exempt. I have not yet received a response. Once we hear word from INAC, and they indicate that the application will be for a Class A land use permit, then I will send you an update.

Please let me know if you have any further questions, and I hope to get back to you shortly with more details if this file will require a NIRB screening or not.
