Thank you for the 2015, 2016 and 2017 annual reports. The historic annual reports from the previous owner are not required, but if any of this information was passed on to your company, it would be useful to provide it to us.

The total amount owing in water use fees is \$1765, calculated below. This is paid for the right to use water irregardless of the amount used. So it will have to be paid.

Water use fee 2013-2017 = 5 yrs x \$365 = \$1825

Subtract \$30 paid for 2014 and this year = \$60

Total = \$1765

As soon as we have the Inuktituk summary and the \$1765, we will process the application further.
