Hi Trevor

To follow up on the previous email, I have a number of items listed below that will help clarify things for the Board. They are in part overlapping with intervener conments, but will provide a clearer picture of what is needed. I have provided you with 2 weeks, which is what I hope is ample time to put this information together. Please let me know if you have any questions or need clarification. I will be back in the office next Wednesday.

1. Incineration of wastes

Subject: Waste Management

Comment: The incineration of any waste oil and other certain other materials (i.e. plastics) contradicts Part D, Conditions 3 and 6, of Water Licence 2BE-FER1318.

Recommendation: Provide information on waste management to the NWB that includes incinerator specifications, details on incineration process, and a list of all materials that will be incinerated versus those that will be backhauled. Include the written indication that only wood waste, paper waste, untreated wood products, and small amounts (<500mL) of waste oil will be incinerated (i.e. hazardous wastes and/or plastics will not be incinerated).

2. Winter road use

Subject: Operations and Maintenance

Comment: It is unclear if the Applicant intends to use a winter road at any point during the term of the proposed Licence.

Recommendation: Provide the NWB with a 10-year plan for winter road use (if applicable), including any water sources (if any), spill contingency planning, etc.

Spill Contingency Plan

Subject: Spill Contingency Planning

Comment: The Spill Contingency plan requires current contact information, specifics on secondary containment at the fuel storage area, and information covering the winter road.

Recommendation: Provide the NWB with a updated Spill Contingency Plan, including current contact information and winter road operation.

Fuel and Hazardous Waste Containment Area

Subject: Operations and Maintenance

Comment: AANDC Water Licence Inspection Dated August 21, 2014, identifies water accumulation and discharge from the fuel containment area as an issue on site.

Recommendation: Provide the NWB with information on the operations and maintenance of the fuel and hazardous waste containment area that includes details on how the management of wastes and water in this area conforms to Licences conditions. Include measures that have already been taken and ones planned to maintain compliance.

Erosion control

Subject: Operations and Maintenance

Comment: AANDC Water Licence Inspection Dated August 21, 2014, identifies erosion as an issue on site. Recommendation: Provide the NWB with information on erosion control and measures that have been taken to rectify the erosion identified in AANDC Water Licence Inspection Dated August 21, 2014. Include measures that have already been taken and ones planned to maintain compliance.

Final Abandonment and Restoration of the Old Camp

Comment: The status of the old camp is unclear.

Recommendation: Provide the NWB with an update on the state of reclamation of the old camp, including photo and written documentation. Following final Abandonment and Restoration, a final CIRNAC inspection is still required.
