Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters* and the *Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board hereby grants the following license amendment.

The License issued April 11<sup>th</sup>, 2003 shall be amended to allow Starfield Resources Inc. to undertake exploration activities on the KAZ and JR Claim Blocks owned by Wyn Developments that are contiguous to the Starfield Resources Inc. Roberts Lake Property. The Licensee shall within thirty (30) days of the issuance of this Amendment provide to the Board:

- i. An updated Emergency Response Plan, as required by Part G, Item 1 of NWB2FER0305; and
- ii. An updated Abandonment and Restoration Plan, as required by Part H, Item 1 of NWB2FER0305.
