I have discussed the feasibility and logistics for removing the items indicated in your recent inspection report this year with an expeditor in Baker Lake. They indicated that at this time the site would be snow covered and most likely froze-in. They indicated that to assure the site could be cleaned up it would be best to wait until late July 2013. Therefore, to answer your question, Uravan would not be able to remove the items from the site this year but would endeavor complete this task no later than August 15, 2012. I can confirm this undertaking in a letter or if you have a standard protocol 'Compliance Plan' please forward a copy. Also, I have contact the Nunavut Water Board and they have provided me with an application for cancellation of the water license.
