| Work between May 15 and July 15 in the Caribou Protection Area | <p>a) UraVan shall not, without approval, conduct any exploration activity on its land holdings during this time. Upon approval UraVan will work past May 15 deadline and if monitoring information suggests approaching caribou, UraVan will cease operations and remove all personnel.</p> <p>b) Work will resume before July 15 within the Caribou Protection Area if the area in question is not expected to be utilized by caribou cows.</p> | <p>UraVan Minerals will be working within the protection area, and only with an approved permit</p> <p>A constant monitoring of the UraVan Minerals camp and surrounding drilling area will be done to ensure there are no Caribou in the area. If Caribou come into the area, the following actions will be taken:</p> <ul style="list-style-type: none"> • Cease any activity in the UraVan Minerals camp and/or drilling area that may hinder the migration or calving activities of the caribou • Ground the drill and accompanying helicopter are grounded for the time that the caribou are in the area |
| Caribou Calving outside the designated Caribou Protection Area | <p>b) If calving occurs outside the Caribou Protection Area work will cease in any areas in which cows and calves are occupying, within the land designated by the Land Use Permit between May 15 and July 15.</p> <p>c) In the event that the cows and calves remain on the property outlined in the Land Use Permit, overhead flights lower than 300m and the use of snowmobiles/ATVs outside camp limits will cease.</p> | <p>A constant monitoring of the UraVan Minerals camp and surrounding drilling area will be done to ensure there are no Caribou in the area. If Caribou come into the area, the following actions will be taken:</p> <ul style="list-style-type: none"> • Cease any activity in the UraVan Minerals camp and/or drilling area that may hinder the migration or calving activities of the caribou • Ground the drill and accompanying helicopter are grounded for the time that the caribou are in the area |
| Caribou Migration through area designated in the Land Use Permit | <p>a) No activities or structures will be placed to hamper or substantially divert caribou migration.</p> <p>b) Overhead activities, equipment moves and airborne surveys, will not occur until the caribou migration has ended.</p> | <p>UraVan Minerals has done it's best to place the exploration camp out of the way of the natural migration path of the caribou.</p> <p>If Caribou come into the area, the following actions will be taken:</p> <ul style="list-style-type: none"> • Ground the drill and accompanying helicopter are grounded for the time that the caribou are in the area |
