On March 14, 2008 the Nunavut Impact Review Board (NIRB or Board) received Uravan Minerals Inc.'s (the Proponent's) Land Use Application for its proposed Garry Lake Uranium exploration from the Kivalliq Inuit Association. On April 1, 2008 NIRB received a positive conformity determination (Keewatin Regional Land Use Plan) from the Nunavut Planning Commission for this project proposal. NIRB has assigned this project proposal file number **08EN037**.

On April 3, 2008 the NIRB commenced Screening for the above project proposal and requested additional information from the Proponent. On April 14, 2008 the NIRB received the requested information, which included the following documents:
