Dear Mr. Kaniak:

Thank you for your letter earlier today granting approval to construct the two sumps at the Goose Lake Camp. You should be aware that we have requested that the Nunavut Water Board (NWB) reconsider their requirement for a sump for greywater, as it is believed that letting the water disperse over the ground surface, in the vicinity of the proposed greywater sump, will achieve more desirable results than placing the water in a sump. This will also result in less overall disturbance to the area.

Should the NWB determine that the greywater sump is not required, we will not construct it. Should they determine that they still prefer the sump, we will construct it pursuant to the approval letter from yourself dated June 28, 2001, and will comply with all conditions of that approval.

Thank you very much for your timely response to our submittal.
