Hello Richard,

Sabina Gold & Silver Corp. (Sabina) would like to request a renewal and extension to our Type B Exploration water license 2BE-G001520 for the Goose property at the Back River Project (the Project). Sabina is requesting a renewal/amendment of the license for a further 15 years from February 19, 2020 to February 18, 2035 to allow for continued exploration in this area,

concurrent with the development and operation of the Back River Project mine. Sabina notes that activities related to the Goose land Airstrip, Airstrip Quarry and Ice Road connecting the camp to the airstrip quarry will now fall under water licence 2AM-BRP1831, as committed in Sabina's Back River Project Type A Water Licence Technical Meeting Commitment Responses; WTM-COMMITMENT 5 (NWB-5). Sabina has not identified any necessary amendments to the terms and conditions of 2BE-GOO1520 related to this reallocation.

The application package was provided to the NPC for a conformity determination on October 8, 2019, and received confirmation that NPC were reviewing the file on Nov. 13th.
