i've been trying to find where we came up with the definition for "trenching" which we've included in licences as "mechanized trenching" using mechanical equipment such as backhoes and dozers. I believe it had come from an INAC page but can't locate it at the moment. From what you describe below, what you are proposing is no different from prospecting and sample collection using hand tools, it just so happens that where you wish to obtain the samples from is within the "previously excavated" trench. If no mechanized equipment is to be used, then I would think collect away!
