Background

The Goose Lake project is located in the Kitikmeot Region of Nunavut 160km South of Bathurst Inlet. The Goose Lake Project is part of the much larger Back River Project which includes several other properties. Goose Lake will be the operational base for drilling activities at Boot Lake, Boulder Pond, Wishbone Trend and Del Lake claims. It is also the base of operations for George Lake; however, George Lake has its own Water License. Existing facilities at Goose Lake consists of an emergency gravel airstrip, jetty/floating dock, 4 helipads and other site structures associated with running and maintaining a drilling operation that can accommodate a maximum of 80 people.

Recommendations/Comments

1) The Proponent is required, since not all water will be taken from the same source, to submit to the NWB the location (GPS Coordinates) of the four drills and where they will be sourcing their water from for the upcoming season. As well, these water sources are required to be adequate for the operations being undertaken.

Also these locations are to be updated anytime drilling activities move.

2) Question 21 of the supplemental questionnaire is required to be answered.





Sabina Gold and Silver Corp. are required to provide the Nunavut Water Board all outstanding information referred to above in order to comply with the Renewal Application process.
