The agreement to submit an Annual Reports, pay water usage fees, spill plans and AR plans was made between Bluestone Resources and the Nunavut Water Board (NWB), if you feel these commitments should no longer be required or you are unable to fulfill these agreements, please consult with the NWB. My function as an Inspector in the Water Licence process is to ensure compliance and conduct on-site inspections. If Bluestone Resources and the NWB determine that this reports/fees are no longer required I have no concern but, until that has been resolved it is still required under the Licence, seen as an act of non-compliance and potentially subject to Section 90 Offences and Punishments of the Nunavut Waters and Nunavut surface Rights Tribunal Act.
