The Nunavut Water Board (NWB or Board) has completed its preliminary review of the application and supporting information (Application) received on April 4, 2014, from Aura Silver Resources Inc., for the renewal of water Licence 2BE-GRE1314.

The review determined that the following information is required before the Board could proceed to the next stage(s) of the licensing process for the Application:

1. Copies of 2012 and 2013 Annual Reports complied for the Greyhound Project as required under Part B, Item 2, in the Licence. For information purposes, a copy of the NWB's standard annual report template has been attached to this email.
2. Copy of the updated Spill Contingency Plan required under Part H, Item 1 in the Licence.

4. Copy of the Licensee's response to Aboriginal Affairs and Northern Development Canada's (AANDC), 2012 Inspection Report.
