The Nunavut Water Board (NWB or Board) has completed a technical review of the Revised Spill Contingency and Revised Abandonment and Restoration Plans (the Plans) provided to the Board on February 4, 2019 to fulfill the requirements of Part H, Item 1 and Part I, Item 1 of the Water Licence No. 2BE-GRE1621.

On February 4, 2019, the NWB acknowledged receipt of the Plans and made them available to the Kivalliq distribution list for information. On March 4, 2019, Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) provided their comments to the above stated submissions.

The Board strongly recommends that the Licensee consult the comments submitted by CIRNAC<sup>1</sup> and attached to this letter, and address these recommendations within the next versions of the Plans to be submitted for Board's approval within sixty (60) days of issuance of this letter.
