The Nunavut Water Board (NWB) has completed its preliminary technical review of the above mentioned application, which determined that the following items needs to be addressed before the application could proceed to the next stage of the licensing process:

1. The Abandonment and Restoration Plan (A&R Plan) must be updated to address the following:

The 2015 Inspection Report states a compliance issue related to the restoration of drill sites. The A& R Plan should be revised to reflect the site current situation related to the restoration of those sites.

2. Greyhound Exploration Project submission made by AEM should be clarified, please provide a clarification of the current situation.

3. Confirmation on whether or not all precicensing issues have been addressed including an updated determination from the Nunavut Planning Commission (NPC) and the Nunavut Impact Review Board (NIRB) regarding the project
