Subject: 16-HCAA-00059 - Camp and Drill Exploration, Hackett River Project, Kitikmeot Region, Nunavut

The Fisheries Protection Program (the Program) of Fisheries and Oceans Canada received the Type "B" Water Licence Renewal Application which has been reviewed under the Fisheries Act and the Species at Risk Act.

Based on the information provided, the proposal has been identified as a project where a *Fisheries Act* authorization is not required given that serious harm to fish can be avoided by following standard measures, and a Permit under the *Species at Risk Act* is not required since there are no Species at Risk near the project site. Proposals in this category are not considered to need an authorization from the Program under the *Fisheries Act* in order to proceed.
