Dear Ryan,

This letter will serve to advise you that Sabina Gold & Silver Corp. will be resuming operations for the season at the Goose Lake camp (the "Back River project") and Hackett River camp (the "Hackett River project") on or about February 15, 2010.

Limited personnel (maximum of 10) will be on site for the first 2 weeks, with initial activity limited to camp opening tasks, such as snow clearing, warming up buildings, starting equipment, etc. It is anticipated that the drillers will be arriving on site in early March, with the drilling program commencing on or about March 15 for the three Projects. For the 2010 program, Wishbone exploration activities will be supported by the Hackett River camp and Del Lake



exploration activities will be supported by Goose Lake camp. Regional maps showing planned drilling areas are attached for your reference.

Additional activities planned for late February and early March are the establishment of winter road connections between Goose Lake and George Lake camps, and between George and Hackett River camps. These will facilitate an efficient resupply of the camps and a redistribution of equipment and supplies.

The 2010 program also includes progressive reclamation activities at all the projects, in particular at George Lake camp. Also included are on-going camp improvements at Hackett and Goose camps to support the 2010 program that will build on our commitment to providing safe working conditions and minimizing impacts to the local environment.

As per the terms of various licenses (above), best management practices and monitoring are part of Sabina's exploration program.

We currently anticipate closing camps in mid to late September and will advise you of the date as we complete our exploration program for 2010. We are looking forward to a safe, successful season at our projects in the Kitikmeot Region again this year, and we look forward to continuing to work with all of you.





Figure 2: 2010 Planned Drilling Areas for Sabina - Wishbone Project
