Following is an update on your file:

- 1. Water use fees have been paid up to 2012. \$189.80 was due on May 27, 2013 for an authorized use of 52 m3/day.
- 2. Annual reports have not been received on this file to date and are required for 2011 and 2012. The 2013 report is not due until March 31, 2014. I have attached a copy of the form to use when submitting the annual report. If there was no activity on site you can simply indicate this on the form for the year being reported. As for the leaking drums noted by the AANDC Inspector, just the date of detection should suffice.
- 3. I've attached a copy of your licence. Please refer to the sections on Spill Contingency Plan and Abandonment and Restoration. Addendums were to be submitted but have not been received. Also attached is correspondence relating to the spill plan and clean up requirements. I trust this information is useful,
