Re: Licence No. 2BE-HEE0712: Submission of 2007 – 2013 Annual Reports, Spill Contingency Plan, and Abandonment and Restoration Plan by Canterra Minerals Corporation for the Heeqou Property Project

Dear Ms. Chadwick:

The Nunavut Water Board (NWB or Board) has reviewed the 2007 – 2013 Annual Reports that Canterra Minerals Corporation (Diamondex Resources Ltd.) filed with the Board for the Heeqou Property Project, located approximately 220 kilometres south southeast of Kugluktuk within the Kitikmeot Region of Nunavut. The review determined that the reports are generally acceptable and consistent with the reporting requirements under Part B, Item 2 of Licence 2BE-HEE0712. The review noted that the camp facilities associated with the project was removed in August 2008 and that the site was unoccupied for the 2007 and 2009 to 2013 reporting periods.

In addition to the above-mentioned reports, the NWB has reviewed and accepted the revised Spill Contingency Plan (SCP) and the revised Abandonment and Restoration Plan (A&RP) submitted subsequent to the issuance of the licence as previous versions of these plans were approved with the issuance of the renewed licence in September 2007.
