Hi Don,

I can confirm that we do not intend to intersect any streams with the proposed tundra strip.

Water use at the High Lake camp typically averages about 1.8m³ to 5.0 m³ per day. I would expect similar water usage at the MolyMag Camp. The water source at the High Lake camp is High Lake itself. The water source at the proposed MolyMag camp would be the James River.

In terms of drilling, water use is estimated to be 25 m³ per day, per drill. Our application requests the use of 2 drills, for a water use total from drilling of approximately 50 m³ per day.

From these estimates, I would expect water use from all activities to be within the 100 m³ per day requested.
