Dear Mr. Rickard:

I am aware of the fact that CLEY has missed the window to officially comment on the MolyMag Campsite proposal; it is unfortunate I was away on annual at the time of this review and this task apparently was not delegate to others by my superior. Going over the history of this project and the water and land use licenses it is apparent that MMG's predecessors have been informed about the presence of archaeological resources in the project area. From experience I know that this information is not always forward to the current owner/ operators and therefore I am contacting you to inform you that there are archaeological sites within your development area and that these sites cannot be disturbed and are protected by law.

I would recommend two courses of action, the first would be to enter in to a data sharing agreement with CLEY in order to obtain the archaeological site locations (see attachment) and secondly would be that MMG should hire an archaeological consultant to conduct a site inventory of development areas(attached list of consultants).
