Dear Mr. Neill:

The Nunavut Water Board acknowledges receipt on February 13, 2003 of your water licence renewal for the above project. Your application included the following items:

- cover email dated February 13, 2003
- application form
- supplementary questionnaire

In order to complete your application we require the information as requested in an email from Jim Wall, Technical Advisor, dated March 7, 2003. We also require your application fee of \$30.00 in cheque form, made payable to "Receiver General for Canada".

This project is currently being screened by the Nunavut Impact Review Board for their determination as to whether they require further review, or if it can be processed by the Nunavut Water Board.

I have been asked by the Board to inform you that a notice of your application is required. This notice of requirement is based on Article 13.3.14 of the Nunavut Land Claims Agreement (NLCA), which states that the Board should take "...all steps necessary by way of notice...to provide and promote public awareness [of hearings]."

Accordingly, a notice in both English and Inuinaqtun will be posted for a period of 30 days, with local establishments in Cambridge Bay, Umingmaktok and Bathurst Inlet. Copy of the notice will be available to you during the distribution process.

Upon request from the public, we ask you to make available, free of charge, copies of all documents pertaining to this application. Any person who is affected by this application or
