# LICENCE AMENDMENT No. 1

Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada*, the Nunavut Water Board hereby grants the following license amendment.

The License issued July 29, 2003 shall be amended to include the following:

## **PART F: CONDITIONS APPLYING TO DRILLING OPERATIONS**

**Amend Item 2** No land-based drilling is to be done within thirty (30) metres of the high water mark of any water body unless otherwise approved by the Board. Land-based drilling within thirty (30) meters on the high water mark of the High Lake, as identified by the Proponent in their submission of September 1, 2004 is approved. All drill waste from the 2 proposed 25 m geotechnical bore holes shall be removed to a disposal sump located greater than thirty (30) meters from the high water mark of the water body. Drill waste from on-ice drilling shall be removed from the drill site.

**Unless otherwise referenced above, all terms and conditions of the License NWB2HIG0305 dated July 29, 2003 still apply.**
