General Background Information on the Project (*optional):

The site dates to the 1950s when the High Lake gossan was first identified by then Texas Gulf. It has since been explored by several groups. MMG acquired the project through a series of transactions starting with the purchase of Wolfden Resources by Zinifex in 2007. Zinifex later became Oz Minerals and subsequently was bought by MMG in 2009. The last exploration activity conducted from the site was carried out in 2013. The site saw limited occupation over the next two years while reclamation work was carried out. The last occupancy was August 2015, and as of this time the footprint was effectively reduced to the surface lease. Closure of land use permits with both KIA and AANDC was applied for at this time. MMG received approval for closure of KIA permit KTL308C008. AANDC approval for closure was originally expressed informally but later questioned and subsequently observed. The LUP N2011C0033 is still awaiting closure sign off. The water license was renewed in 2017, as the site is considered a strategic location from which to base engineering and environmental work related to the Greys Bay road proposal. The most recent site visit was made in August 2019.
