A. Background

The Hope Bay regional exploration project, under which the water licence 2BE-HOP12222 was issued, is located approximately 100 km south of Cambridge Bay and 50 km east of Umingmaktok in the Kitikmeot region, Nunavut.

The Licensee is seeking to renew their current water licence due to expire on June 30, 2022 for another 10 years, and update some terms and conditions in the existing water licence to reflect the current changes in the project.



C. RESULTS OF REVIEW

CIRNAC provides the following comments and recommendations for the Board's consideration:

1. Amendment to Water Licence 2AM-DOH1335

Comment:

In Part A, Item 1, the licensee is proposing to strike out the following phrase from the

"the temporary use of water from Windy Lake and transport to the Doris Camp via winter road for potable use until the new treatment system is commissioned at the Doris Camp."

The licensee in its rationale stated that: "The water used by the Doris camp is no longer drawn under the licence 2BE-HOP1222, but under the 2AM-DOH1335."

Furthermore, in the rational given to the propose changes in Part C, Item 1 on the quantity of daily water usage for camp and drilling purposes, the licensee stated that the Doris camp and water used for suppression of dust is now covered under the water licence 2AM-DOH1335.

It is not clear if the licensee has amended water licensee No. 2AM-DOH1335 to reflect these modifications or planning to do so.

Recommendation:

(R-01) CIRNAC recommends that the licensee provide clarifications on whether they have amended water licence No. 2AM-DOH1335 or planning to apply for an amendment to incorporate these changes.
