SUMMARY

ENVIRONMENTAL EMPLOYEE OF THE MONTH AWARD

The Environmental Employee of the Month Award for May was awarded to Surveyor, Jay Hallman (see Photo). This award is presented to a selected MHBL and long-term contract employees in recognition for being proactive in suggesting, implementing measures or taking appropriate actions that promotes environmental stewardship on the Belt.

Jay was the Environmental Employee of the month recipient of a polo-T-Shirt. Jay over the years at Hope Bay has been instrumental in suggestion and taking appropriate actions in pointing out environmental concerns to appropriate personnel. His continued effort has not gone without admiration from his peers. Jay was nominated by Project Resource Managers Dave Smith and Percy Pacor for May's award.

ENVIRONMENTAL INCIDENCE




Figure 1: Reported Incidences by Month




Figure 2: Reported Incidences by Organizations

Six environmental incidences were report during the month along the Belt, which bring the total number of reported incidences to sixteen for 2007 as tabulated in Table 1. All of the reported incidents were spills of less than 25 litres. Figure 1 shows reported incidences by months. April and May recorded six incidences respectively. A lot of fuel movement and handling was carried out during these months. Figure 2 shows reported incidences by organizations. Kitnuna reported seven incidences, MHBL reported five and Major Drilling reported four. Most of these incidences were reported from carrying out workplace site inspections and from concern employees.

DOMESTIC WATER SOURCE

Potable water drawn from Windy Lake and Spyder Lake for camp use is presented in Table 2. The daily water usage at Windy Camp averaged at 18.2 cumes. The year-to-date cumulative water abstraction for Windy Camp use at the end of May is 1,305 m³. At Boston, the daily average was 7.9 cumes. Year-to-date abstraction is 261 cumes. Daily usage rates at each camp are within the respective compliances values.

NON-COMBUSTIBLE WASTES

Removal of non-combustible wastes continued during the month. Table 3 shows the non-combustible waste material backhauled off site. At Windy Camp, a total of 44,545 lbs of non-combustible wastes were

backhauled to Yellowknife in May compared with 35,200 lbs in April. At Boston Camp, 23,045 lbs were backhauled in May.

VISITS AND REQUESTS FROM NWB AND KIA

No requests were received from either Nunavut Water Board or Kitikmeot Inuit Association during the reporting period.
