## Re: January 2019 – Monthly Monitoring Report for Water Licence 2BE-HOP1222

This report is comprised of monitoring requirements as set out in Part J, Items 2 through 8, and 10 of water licence 2BE-HOP1222. Some monitoring requirements stipulated in this Part refer to facilities that have not been constructed, facilities that no longer exist, or facilities where activity is seasonal. Water levels in Windy Lake will be monitored in accordance with Part J, Item 9 during open water season. Sampling locations monitored under this licence (seasonally or when facilities are operational) are provided in Figure 1 at the end of this report.

During the period of this report, the focus of activities under the Windy Regional Exploration licence was surface exploration drilling, water management and environmental compliance.

#### Part I Conditions Applying to Abandonment and Restoration

No abandonment or restoration work was conducted during the month.

#### Part J Items 2, 3, 4, 5, 6, 10: Sewage Treatment Effluent, Bulk Fuel Containments, and Quarries

Windy Camp has been closed for operations since October 23, 2008 and New Windy Camp has not been constructed. Therefore the licence requirements relating to the Wastewater Treatment Facility (HOP-2 and HOP-3) are not applicable at this time. HOP-5 (Bulk Fuel Storage – Windy Camp) and HOP-6 (Bulk Fuel Storage Facility – Patch Lake) were dismantled in 2012. HOP-8 (Bulk Fuel Storage Facility at New Windy Camp) has not been constructed. Water quality sampling and management was not required at HOP-7A, B or D (quarries A, B and D) as no discharge of water was required from these areas this month.

### Part J Item 7: Under-Ice Drilling Samples

On-ice surface exploration drilling began on Patch Lake in January under this licence. Under-ice water quality sampling was conducted prior to the start of any exploration activities. Results of this sampling are provided in Appendix A attached to this report.

#### Part J Item 8: Water Use Volumes

This month, water was extracted from Patch Lake to support surface exploration drilling. Geographical locations for all water sources and usage is maintained on file. All usage from water sources during the month were metered at the source. Daily water usage for the month is presented in Table 1.
