Attached please find the general Water Licence Application and all supplementary documents as required by the Nunavut Water Board to process the application submitted on behalf of WPC Resources Incorporated for the Hood River Project. The HOODRIVER-001 Mineral Exploration Agreement property lies within CO20 IOL parcel.

Due to the lateness of the submission of the application the 2014 exploration season will be limited to geologic prospecting, geologic mapping and prospecting. Drilling will not commence until late 2015 or early 2016 as the property has to be evaluated by an archaeological survey during 2015.

WPC Resources has negotiated an arrangement with Elgin Mining Inc. whereby WPC crews will be accommodated at the existing and already permitted Ulu Mine Site. No camp will be established on the HOODRIVER-001 MEA Property.

I have strived to make the approval process smooth and efficient by supplying the Nunavut Water Board, the Nunavut Impact Review Board and the Kitikmeot Inuit Association with as much information as possible.
