Thanks for commencing the review of the application.

Blue Star has not yet retained a camp provider so does not yet have a specific model of incinerator procured. Blue Star would be happy to commit to providing the manufacturer's manual once we have that in hand; an appendix to the Waste Management Plan may be the most logical place to capture this. Perhaps a condition in the licence requiring submission of this would suffice.

FYI, Blue Star is familiar with ECCC's batch incineration technical guidance and will take that into consideration when procuring and operating.
