Subject: Licence No. 2BE-HRP1419 – Submission of 2015 Annual Report, Revised Spill Contingency Plan (SCP) and Revised Abandonment and Restoration Plan (A&RP) for the Hood River Project

Dear Mr. Goard:

The Nunavut Water Board (NWB or Board) has completed its review of the 2015 Annual Reports (Report) submitted by WPC Resources Incorporated, on December 7, 2015, for the Hood River Project, a grass-roots exploration project located approximately 200 kilometres southeast of Kugluktuk in the Kitikmeot Region, Nunavut.

The review determined that the Report is generally complete and consistent with the reporting requirements associated with Part B, Item 2, of Licence No. 2BE-HRP1419. The Board notes, as indicated in the report, that no water use or waste deposit activities occurred during the 2015 period as initial onsite activities are expected to commence in 2016.

Additionally, the Board has reviewed the Revised Spill Contingency Plan (SPC) and Revised Abandonment and Restoration Plan (A&RP) submitted as additional information with the Report and determined that the revised plans are consistent with the requirements under Part H, Item 2 and Part I, Item 2 of the Licence, respectively.
