The Nunavut Water Board (NWB or Board) has completed the technical review of the 2018 and 2019 Annual Report (2018 Report and 2019 Report, respectively) (Reports) for Type "B" Water Licence 2BE-HUC1823 (Licence). The 2018 Report was received on January 23, 2019, and the 2019 Report was received on March 13, 2020 from Agnico Eagle Mines Ltd. (Agnico Eagle or Licensee) and submitted as a requirement under Part B of the Licence.

The NWB distributed the 2018 Report and 2019 Report to the Kivalliq distribution list for information on January 23, 2019 and March 13, 2020, respectively. No comments have been received to date.

The Board notes that the Licensee indicated in the 2018 Report the locations of drill holes in lieu of the locations where drill Waste was deposited. The Board reminds Agnico Eagle of the requirement in Part J, Item 3 of the Licence: "(t)he Licensee shall determine the GPS co-ordinates (in degrees, minutes and seconds of latitude and longitude) of all locations where Wastes associated with camp operations and drilling operations are deposited." Therefore, the

Board requires that the Licensee provide the missing information in the 2020 Annual Report to be submitted on or before **March 31, 2021**.

The Board notes that no activities were undertaken at the Huckleberry Exploration Project in 2019.
