
It has been determined through a conference call on Monday June 17, 2013 between representatives from the Kitikmeot Inuit Association (KIA), The Mackenzie Valley Land and Water Board/ Wek'eezhii Land and Water Board (MVLWB/WLWB) and the Nunavut Impact Review Board (NIRB) that the land and water use will be governed by either the MVLWB or the WLWB.

Therefore with respect to the application as submitted please only take into consideration the camp and drilling water usage solely defined for the Itchen Lake Property.

My apologies for overlooking to request an invite for you (or another representative from your office) into the conversation. I have cc'd the other members of the meeting in order to hopefully keep an open means of communication between all governing agencies involved.
