## **Technical Review Memorandum**

**Re: 2BE-IZO1217 – Request for Open Burning – Izok Lake – MMG Limited (MMG).**

### **Background**

The Izok lake project is located in the Kitikmeot Region of Nunavut. MMG currently has facilities and infrastructure to support the running and maintaining of an advanced exploration drilling operation. At this time MMG is planning on putting this site into a care and maintenance phase including reducing its project footprint by carrying out certain reclamation activities (i.e open burning).

### **Recommendations/Comments**

As part of the recent program review, AANDC recognizes that enforcing conditions related to open burning within water licences may be outside of the jurisdiction of Inspectors appointed under the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* (NWNSRTA).

This determination is made where there is no clear connection between an activity and water use, deposit of waste to water or related appurtenant activity as set out in the NWNSRTA and *Nunavut Waters Regulations*.

With respect to the activity of open burning, AANDC's jurisdiction is limited to the prevention of deposition of waste materials of combustion and/or leachate from contaminated ash residual impacting any surrounding waters, unless otherwise approved by the Board in writing.

AANDC would like to assure the Nunavut Water Board that there are competent regulatory authorities that exist within Nunavut with the necessary legislation and jurisdiction to address any condition related to burning or incineration that may be beyond the jurisdiction of AANDC Field Operations.



AANDC would also like to encourage the proponent to seek out the existing federal, Inuit, territorial or municipal regulatory authority in Nunavut for further guidance related to the permitting of this activity.
